Update on St. Paul's Trees

On Saturday June 18th Linda Glick Forster, a local Arborist and Tree Risk Assessor, visited St Paul's to assess our trees. Recent storms have caused significant tree damage in Columbus and the Flowering Pears at the back of the church were a particular concern.

Below is a summary of her assessment, a full report from her is expected. Further discussion by Vestry and Finance is needed before we implement these recommendations.

The 6 Honey Locust trees on California Street need to be trimmed. One tree has a deteriorated limb that should be cut off and treated for carpenter ants. All have dead wood that should be removed to encourage new growth.

The 3 pin oaks on the South Side of the building need to be treated in the fall with a Magnesium and Iron soil drench. Bartholomew County soil is not kind to pin oaks, but they will recover. These trees have been fertilized to help them through the summer, but should not be trimmed until next year.

The 6 Ash trees on the North Side of the rear parking lot are either dead or dying from Emerald Ash Borer. They should be cut down and 3 replacement trees planted further from the powerlines.

4 of the 6 Flowering Pears between the church and back parking lot should be cut down and replacement trees planted. These are old and overgrown trees, and pears are prone to breaking branches. 2 trees are too close to the church, 2 have large branches overhanging the parking lot, and the middle 2 can be trimmed and kept for the time being to provide shade until the replacement trees are established. Bradford and Flowering pears

were popular landscape trees when they were planted but they are not native to Indiana. They are classified as an invasive species, and their limbs are prone to storm damage.

The 1 honey locust tree on the North-East corner on the church should be trimmed and all dead limbs and dead wood removed.

7 more Flowering Pears exist around the rear parking lot. The 3 in the middle of the black top could be replaced by bushes, but there is a light pole in the middle of this bed (ownership uncertain) that we need to work around. 4 other trees on the South Side (next to the pin oaks) can be kept for now.

Linda recommended we mulch all the trees we plan to keep long term. Mulching retains moisture and protects the root system. This work has already started.

Linda also talked about Replacement trees including Black Gum. Magnolia, and Maple instead of Ash. She encouraged us to not replace one tree with another but think about location and to not plant all one species. We will find that replacement trees are in short supply and should work with local nurseries to obtain native and other suitable trees.

Judith was a grants officer at Trinity Church, Wall Street for many years serving on the African desk. It was she who was able to arrange for the Bishop of Bor to come to St. Paul's when he was in the Diocese of Indianapolis. Judith lived for nearly 30 years in a rent-controlled apartment in the upper 80s in New York. She was to retire from her job at Trinity on September 11, 2001. When the towers were struck her retirement party was interrupted and she was escorted by security into a basement at Trinity to be kept safe. After some time, she decided she'd try to get home. She began to walk through the dust and confusion making her way north as best she could. No busses were running nor cabs to be found so she said she knew she was in for a long trek. She would stop at benches to rest and at one stop a restaurateur came out and spoke to her. Realizing her plight, he brought her out some food and drink but refused her attempt to pay him. She finally reached her apartment looking forward to nothing more than a bath and a long rest. As she entered her apartment, the phone was ringing. When she answered, the voice at the other end said, "Judith. This is Desmond. Are you all right?" It was Archbishop Desmond Tutu whom she knew well form her work in Africa. She was the first person he thought to call when he heard what had happened in NYC.

Another story she told had to do with her decision to retire to Indiana. She worshipped at Holy Communion Church in NYC. One Sunday morning at coffee hour, she was standing in line to get her coffee, discussing with someone her plan to retire to the Franklin, Indiana area near where she had kinfolk. A voice behind her spoke up saying, "Oh, Columbus is a lovely city and they have a wonderful church with a great priest." She said she turned around and found herself talking with Nancy Schacht. She said it was that conversation that convinced her to move to Columbus. And the rest is history!

Isn't that just an AMAZING story!?!? Thanks to Peder for sharing that!



The meeting began at 6:30 PM with a prayer by Frank and the Check-In: Special Events for Q3 and Q4. Events noted include parish picnic in early October, ice cream social at school early August, guest speaker Ben Blayson from Bloomington on Climate Change and energy savings, and a Christmas concert.

Procedural Business

There was a quorum. Motion made by Shelly to approve May minutes, Barb seconded, approved. The next vestry meeting is set for July 12.

Finance Report

Frank reported that all looks good, partially due to the number of pledges prepaid.

Cindy Overmyer, treasurer, had sent a draft document on guidelines for established funds and gifts. Julie asked if there were guidelines on what gifts can be accepted or which cannot. Barb noted this is already covered in guidelines. ACTION: The draft document will be revisited next meeting.

Old Business

Shelly reported that the congregational survey is in progress and that she plans to send one to each member of the congregation, then analyze the results. Discussion followed on possible questions for the survey, including service times.

New Business

There was no new business.

Reports

Re-Opening Committee: Kelli noted no new changes.

Buildings and Grounds:

Signage: Andrew is trying to meet with Victoria Bell and others for ideas to make a plan.

Altar Steps: Frank said there has been no progress yet but a number of ideas have been presented to him. Discussion followed. ACTION: Frank will continue to pursue ideas.

Trees: Andrew talked to two arborists about the state of the trees on our property. Shelly suggested going with Linda Glick Forster. ACTION: Andrew will schedule a meeting and walk through with her.

Cleaning Issues: Andrew talked with Nancy Morris who knew of no issues; Kelli agreed. Julie noted that the altar floor needs cleaning.

Clean Up Day: It did not happen last week as scheduled, and no new date has been set. Discussion followed noting areas in need of attention, in addition to earlier named ones such as trees, painting vesting room, cleaning bathrooms, etc. ACTION: Andrew will list individual tasks needing attention and then ask for congregational members to sign up to take care of them on their own.

Status of AC in Sanctuary: Andrew reported that the AC has been fixed. ACTION: Andrew will contact Loesch to get a quote on bringing the system up to date.

Church Buildings for Collaborative Partnership: Andrew explained the diocesan program which encourages churches to sign up to find new or additional uses for their buildings. ACTION: We will sign up, and a committee will be formed to follow through.

Marketing

Square Space Website: A recap of last night's Website meeting was given in which a recommendation was made for the vestry to accept the amended Q7 plan for \$8,000. Motion was made by Shelly to accept, Frank seconded, approved. Julie, who had worked with Q7 to lower the price, asked that if later we could use the part deleted (getting new members, etc.). Discussion followed. Julie noted that meeting with Q7 would begin quickly and she was willing to be the point of contact for St. Paul's. A committee consisting of Julie, Kelli, Barb, Melissa zur Loye, and Shelly was named for the project. Shelly emphasized that the Website project was an investment in the future of our church. ACTION: Andrew will announce the Website project Sunday. Julie will give Q7 a deadline of Aug. 5 for completion.

Upgrade of Information on current website: Melissa had reported to the Website committee at last night's meeting that she had contacted three churches for ideas, and that she has worked with John Settle on upgrades.

Outreach

Andrew reported he is seeking a guest speaker for Sunday, July 17 who would speak from experience about Fish and Love Chapel. Barb gave dates of Sept. 7 and 14 for Hot Meals for Love Chapel. The meals are being prepared at Free Methodist Church, and delivery volunteers are needed.

Kelli had no update on the Altar Guild. It was noted that 3 St. Paul's members attended the Presiding Bishop's Celebration in Bloomington June 4. Andrew reported that planning and officiating worship in July is complete. Shelly suggested posting the Worship Team and Report on the Website so folks know what will be happening once Rev. Kathy is gone. Andrew reported on last Sunday's Ministry of Welcome meeting where revamping of welcoming procedures was discussed. ACTION: Andrew is writing new, simpler, procedures which will include signing the guest registry book on first visit, possibly receiving a packet of information on St. Paul's, follow up, and receiving a St. Paul's mug on third visit.

Rev. Kathy had sent an email documenting her workshop for lay leaders.

Financial Summary



YTD Actual Expenditures are \$61,140 as compared to the budget of \$67,292 for a favorable difference of (\$6,152). Budget and actual do not include investment income or rector search, which have not been used so far in 2022, except for \$102 rector search expense.




