From our Priest

During covidtide, a bishop of the Episcopal Church said, "The church has left the building," which was true. You may already know that the Greek word for "church" does not refer to a brick-and-mortar building, even though that is our contemporary understanding. Back in the day when St. Paul was writing his letters to the early followers of Jesus scattered around the Roman Empire, the word "church" (ekklesia) meant a gathering of people summoned. The first communities of faith gathered in the homes of the faithful, who then would invite their neighbors for a meal and a message. As Christianity grew, the faithful built structures for a common gathering place to worship and celebrate Holy Communion. Church buildings evolved from simple spaces to the beautiful struc-

tures we have today. As we do now, the people summoned for prayer in the early days of Christianity took pride in their buildings. Also, way before the idea of community centers, church buildings were such places for education, Christian formation, the arts, and meeting space for the community.

St. Paul's and other faith communities in the Dioceses of Indianapolis and Northern Indiana are going through training and exercises to recapture the ethos that churches, both the physical building, and Christians, care about their community and want to be a center and resource to their community. This process is more than just clever marketing techniques for promoting St. Paul's. It's about all of us reaching out to the community and building the necessary partnership relationships. This understanding brings us back to that bishop's statement, "The church has left the building."

Faith communities no longer have to adopt an attitude of hope and wait for new people to participate in the mission and ministries of St. Paul's. We can proactively seek and invite friends and colleagues to join us, meaning the church has to leave the building to bring people into St. Paul's. Also, we can invite outside organizations that align with our values to consider



Mahatma Gandhi wrote, "Be the change you wish to see in the world." I will write, "Be the change you wish to see at St. Paul's." Together we can do all this and more with God as our helper.

Formation



These documents are a way to legally declare what our wishes are for medical decisions and life choices, before those decisions are needed. This is especially important if we become incapacitated through illness or age. In those instances these wishes are recorded for our family to carry out. It relieves them of the emotional burden of making hard choices, or making those choices without knowledge of what we want.

We will have booklets available to guide you through the process. These booklets are terrific—written in an easy to understand format providing examples to help us see what choices we have and to think through what our own preferences are.


Empty Bowls Returned — In-Person!

The 25th Annual Empty Bowls fundraiser hosted an estimated crowd of 340 people at Central Middle School cafeteria on Saturday, February 26th. Organizers stated that approximately \$18,000 was raised, but donations are still coming in. That was slightly shy of a goal of 500 people and \$20,000.

Once again, St. Paul's Soupers rose to the occasion, stirring up 8 gallons of Beef Chili to contribute. Our thanks go out to: Brother Ælred Dean, Deborah Elliott, Cindy Overmyer, Lou Wenzler, Kathi Whipker and Melis zur Loye.

This year the fundraiser returned to an In-Person event. Brother Ælred, Stephen Talbert and Barb Parker assisted in the kitchen.

100% of the proceeds from Empty Bowls goes directly to 6 local pantries and shelters: Love Chapel, Turning Point, the Salvation Army, the Community Center of Hope, Thrive Alliance, and Horizon House. Representatives from all 6 agencies were present at the event with information to share.

Financial

Barb reported that finances look good for starting out the new year. Pledge receipts are favorable. A \$25,000 CD was purchased. It was noted that the Parish Administrator was given an increase but that action needed a vestry approval. Nancy M. moved to okay that raise, Andrew seconded, approved.

Buildings & Grounds

Andrew reported that the limestone steps had been fixed by Repp & Mundt and the price had come in under quote. The next step will be recaulking the base of columns. Vestry approved going ahead on the project; Andrew made motion, Nancy A. seconded. Andrew noted that memorial funds had paid for the expense of fixing columns. ACTION: It was decided to have the Finance Committee determine funding of next step.

Andrew noted that good progress was being made on HVAC expenses. A second quote may be sought with Nading Mechanical for 3 heat pumps. Action: An internal meeting should be set up to prepare a list of questions for bidders before any further action would be taken,

Andrew has asked Ken Erickson to report back on the Ring doorbell; Steve suggested putting it on a SSID apart from the office WiFi. That should resolve the hacking vulnerability concern.

Andrew reported that the new lockable mailbox has been mounted on the church wall.




