From our Priest


You might be aware of the Benedictine practice called "Ora et labora," which means "prayer and work" in Latin. The practice of ora et labora captures a balanced approach to life by highlighting the importance of spiritual contemplation (prayer) and daily work (labora). In his book, *The Practice of the Presence of God*, Br. Lawrence wrote, "The time of business does not differ with me from the time of prayer; and in the noise and clatter of my kitchen, while several persons are at the same time calling for different things, I possess God in as great tranquility as if I were on my knees." Both prayer and work are our offerings to God, where work is prayer and prayer is work.

However, you may not be as familiar with the Latin phrase *lex orandi*, *lex credendi*, meaning the law of what is prayed is the law of what is believed and practiced, or praying shapes believing, and our beliefs shape how we practice our faith. *Lex orandi*, *lex credendi* captures the spirit of Anglicanism. How we pray as Anglicans shapes our spirituality and practice. For example, we pray for the hungry and homeless – then we work towards ending hunger and homelessness.

The idea is that prayer shapes our beliefs and actions. Think about one of your favorite prayers from The Book of Common Prayer, and one of mine is: "O Lord, support us all the day long, until the shadows lengthen, and the evening comes, and the busy world is hushed, and the fever of life is over, and our work is done. Then, in thy mercy, grant us a safe lodging, and a holy rest, and peace at the last. Amen"

All the prayers from The Book of Common Prayer and more have shaped us as we have heard them, recited them, read them, and prayed them over the years. How has the one of which you've thought shaped you to be the eyes, feet, hands, and heart of Christ? God bless you!

Formation

Forum

On Sunday, August 27th, we had the privilege of welcoming Lesley Reuter, Vice-President of Congregation Sha'arei Shalom, who led the forum discussion on the importance of Sabbath rest. During the discussion, Bill Monette and John DeLap both pointed out how struck they were by the many commonalities in religions throughout the United States. Lesley had baked a traditional loaf of Sabbath bread with us which Brother Ælred then shared with the congregation during Holy Communion.

Formation Opportunities Ahead

Another word I like to use for Christian formation is stewardship in its complete understanding. Typically, Christian formation is about our ongoing learning in the Christian faith, which it is; however, it is more than learning. For the rest of ordinary time, as we move into Advent, there are opportunities for learning at St. Paul's. During the coffee hour on September 10, come and see what your Vestry and the Buildings and Grounds Commission are doing at St. Paul's. Their faithful work is securing the future of St. Paul's by maintaining and upgrading the property. Also, there will be a series of discussions about the book *Strength for the Journey: A Guide to Spiritual Practice* by Renee Miller. Buildings & Grounds

HVAC Update

The upkeep and repair of our "House" is a subject we as a group have assumed will take care of itself, or at least "someone" will do it. But just as each of you know by our experience at each of our homes, it is work to keep our church and grounds looking good and in good repair. That is not an easy task. It takes effort from multiple people and sometimes resources to pay someone to do the tasks we cannot do. I will explain some of the issues we face throughout the year. Not because you are being asked to participate, but just so you know the issues we are confronted with every week of the year.

The furnace and air conditioning units for the Sanctuary, Sacristy, kitchen, and basement were installed at the original construction of the church. That was about 1959. We have been very fortunate that those units have lasted that long with only minor repair. It's time we faced the task of replacement. The Vestry has agreed and has approved a committee's recommended expenditure to allow that to happen, The work will begin the second week of September.

There have been issues with the outside columns. Repairs have had to be made to keep water from seeping into the foundation of those columns. That is work, some done by volunteer labor, some by professionals. It's expensive and it's a struggle for the Vestry to allocate funds for those projects. It's all part of the effort to keep our house looking and operating in an efficient way.

If you can, take a walk around our little corner of this earth so see how good we look. It's been a long time since it's looked better.

At a September 10^{th} forum after the service, we would like to tell about other plans and the challenges that we may be presented with in the near future.

From the Archivist

Don Wools and others have been clearing out the church basement. He found two boxes he thought I might want to look over but personally he recommended pitching. One afternoon recently I went to church to check those boxes. Indeed, years in a damp basement, acidic paper and helpful spiders and other insects had damaged much of the contents. I did notice a folder concerning the new church, i.e. our present building. Worth a look, especially as the papers were not damaged.

I found a very official document signed by a notary giving the wardens, vestry and rector of St. Paul's the consent and approval of the Bishop of the diocese and the majority of the members of the standing committee to secure a mortgage for the real estate upon which our current church stands. Dated December 4th 1959. As the diocese owns all parish property, having their official consent is legally necessary for such things as mortgages.

Another item, just a half sheet from St. Gregory's Priory in Three Rivers, Michigan. They provided our altar rail and final payment was made April 15, 1965. That rail was removed when the church was remodeled in 2002.

The most fun was a typed bill of sale June, 18, 1965. St Paul's sold a snow cone machine plus wooden booth, ice chest, ice crusher, two wheeled trailer and syrup dispensers! All for the handsome sum of

Outreach Update

Schmitt's Open House

Once again St Paul's hosted an Ice Cream Social for the Students and Parents of Schmitt Elementary School during their Open House. We served ice cream and popsicles along with a small gift for every student. A fun time was had by all.







FISH

In July, we collected money for local Food Pantries in Columbus (Love Chapel) and Seymour. A check for \$2,340 (previously \$1,120 in 2022; \$2,460 in 2021) was sent to Love Chapel, and \$210 (previously \$300 in 2022; \$150 in 2021) to Seymour's Anchor House. Both organizations are experiencing increased numbers as the rise in food prices makes life even more difficult for those living on fixed incomes. Remember: We continue our year-round collection of food. Cans, non-perishable food items, and clean grocery bags can be left in the blue tubs in the office area or Narthex.

Pride Festival

Another opportunity coming up quickly would be to represent St. Paul's at the local Pride Festival in Mill Race Park on Saturday afternoon, September 30th. This requires a loving heart and a smile. We will have a table and distribute brochures during the Festival.



Love Chapel's Worship in the Park

Last year, Worship in the Park was held on Sunday, August 21, at six different parks with thirteen churches participating and roughly 550 participants in all. St. Paul's joined with Columbus Free Methodist Church at Donner Park's Shelter House that Sunday evening. The weather was perfect. Columbus Free Methodist provided uplifting music. St. Paul's provided the Readers for the lessons. The service was followed by an ice cream social.

This year this ecumenical service will be held on Sunday, October 1st. Mark your calendars now and look for more details in the upcoming weeks.

Outreach

Love Chapel July Update

Barb Parker attended the August meeting of the Ecumenical Assembly (Love Chapel). Here are three takeaways from that meeting:

Guest Speaker, Vachel Hudson, CRH – Mental Health Matters

Director Kelly Daugherty introduced Vachel by explaining that they met in a leadership group and that the work of Mental Health Matters will impact guests of Brighter Days as well as many aspects of the community. Vachel has been working with MHM for over three months; he shared information about the different groups that are part of the MHM initiative. The work of MHM is a 3-year process (discovery, implementation, sustainability) and will be similar in format to the substance abuse initiative, ASAP. Discussion included the importance and lack of availability of permanent supportive housing, the stigma associated with mental health needs, and city vs county outreach.



Housing – The number of guests at Brighter Days has dropped some, in part because we have helped several people find permanent housing. Kelly talked to city leadership recently about the need in the community for food and housing, but he was disappointed with their response including their statement that permanent supportive housing would not happen in Columbus because of their fear it would attract more unhoused people to the community. Although current city leadership was disappointing, with the coming Second City class, the City Council will have more of a leadership role, and Kelly has already had positive responses from City Council members/members elect. We discussed

the increased presence of unhoused people in the community.

Finances – Steve Fisher, Treasurer, shared copies of his report and discussed July and 2023 year-to-date results, current cash position and the status of the Indiana HIPP grant funding. Income/donations were high in July, but expenses were over budget primarily because EAF food expenses have been high given current service needs in the community.




Fun Fact: Did you know that "Love Chapel" and "The Ecumenical Assembly of Bartholomew County Churches" are the SAME THING?


